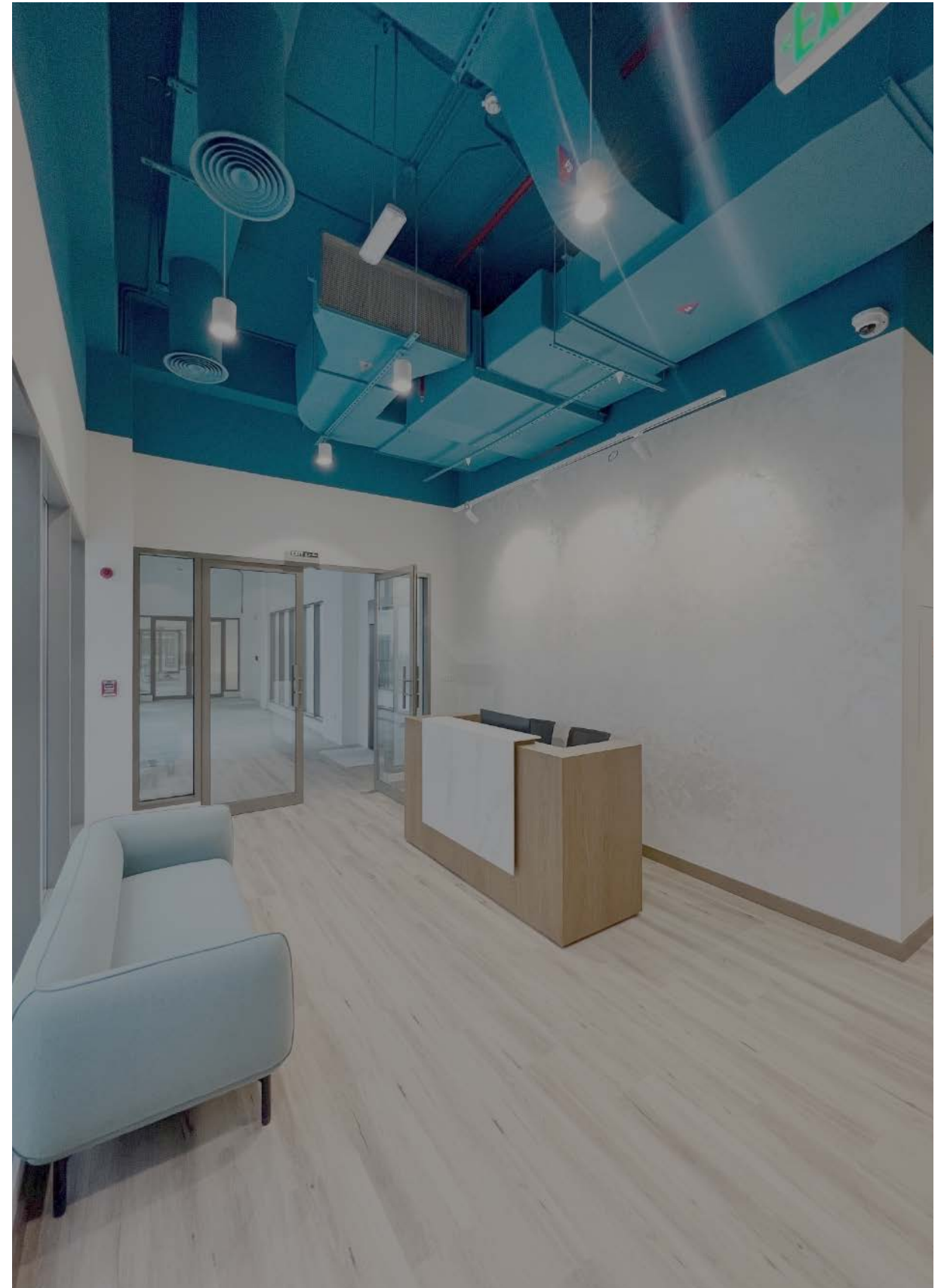

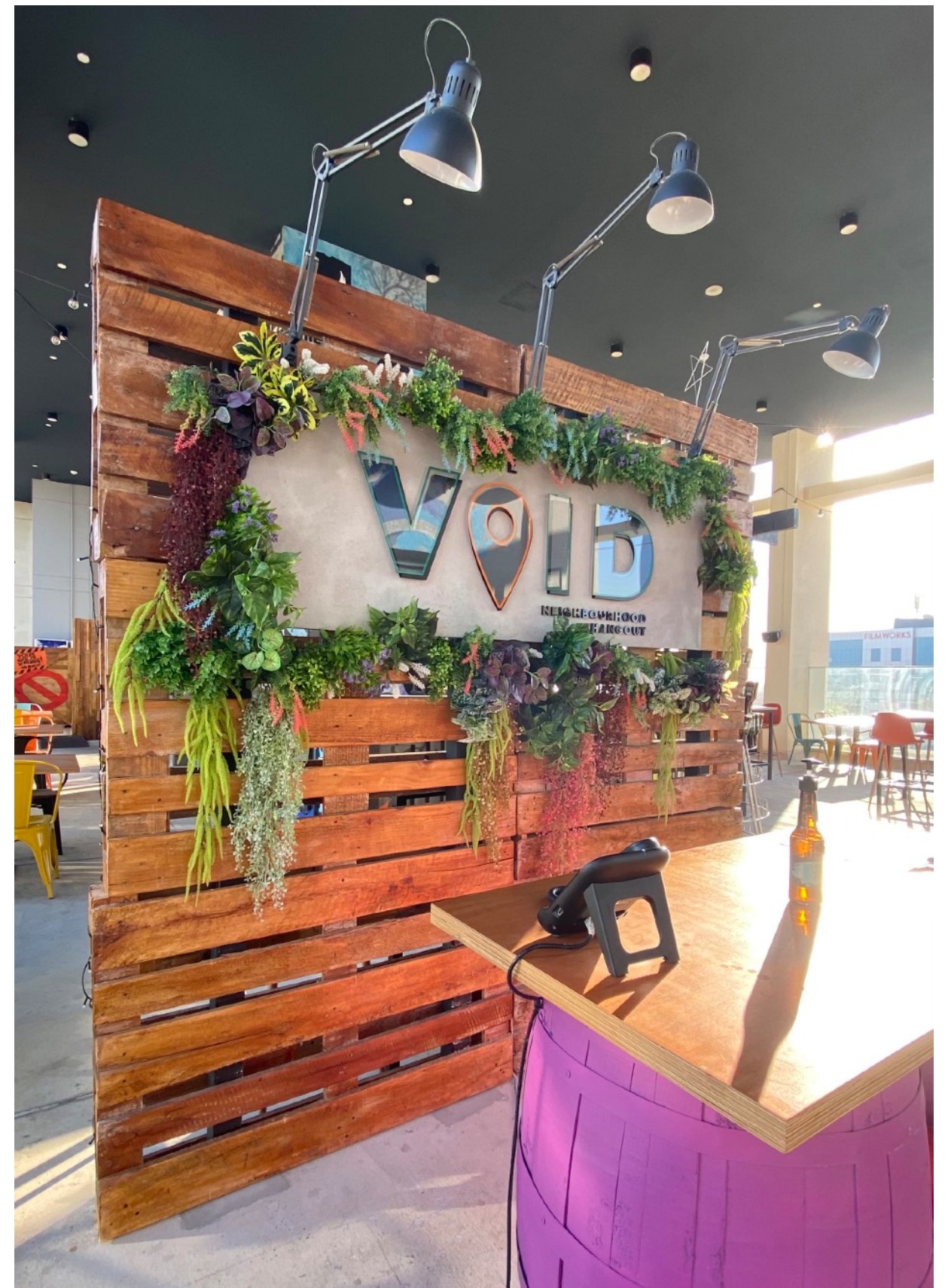

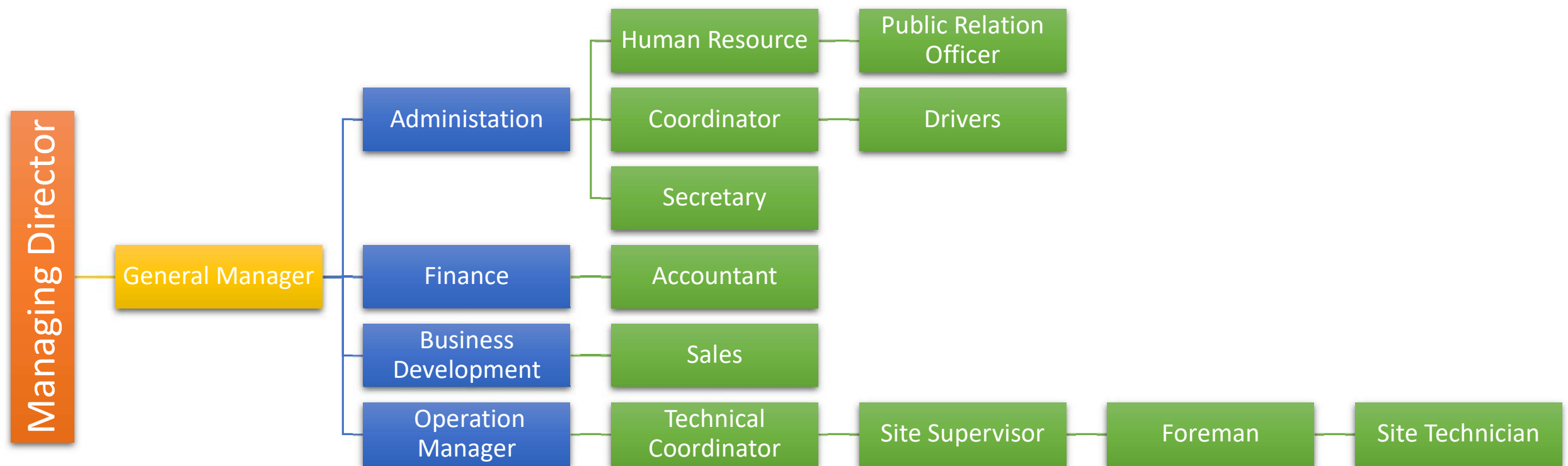




FIT-OUT PROJECT

PROJECT SAFETY PROCEDURES

Any breaches of procedures or gangrenous situation will be notified to the responsible party and corrective action will be taken against the activity halted due to this result.

First aiders will be available to all on site and the first aiders will be identified. Emergency procedures will be dependent on the configuration and layout of permanent and temporary works and will be addressed at the safest access / exit in the case of fire.

House keeping and tidiness will be the responsibility of the foreman. Subcontractors will be required to involve in an effective housekeeping policy on site.

Visitors will not be allowed on site without personnel precautions equipment and they will be accompanied by GreenGuard Group personnel.

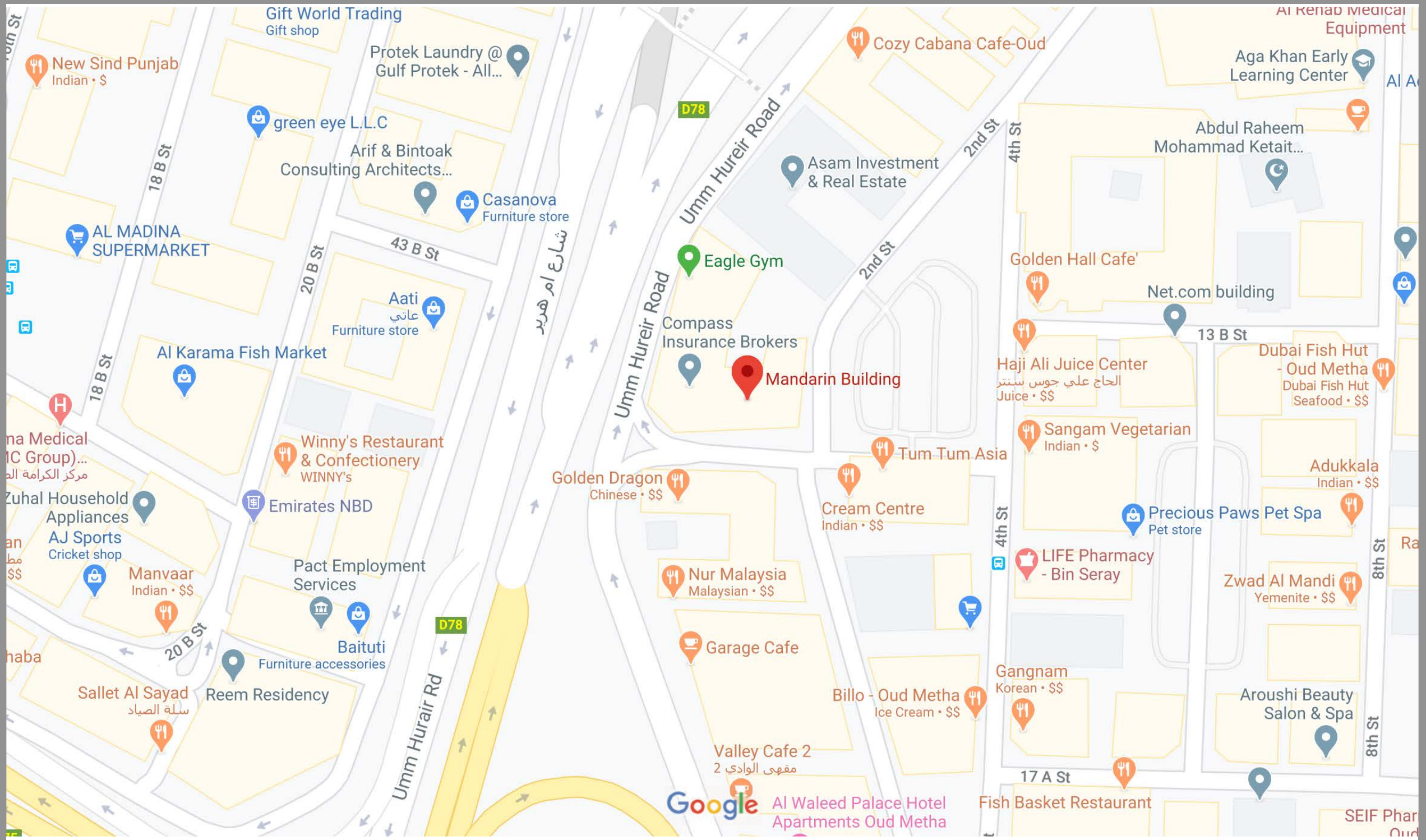
