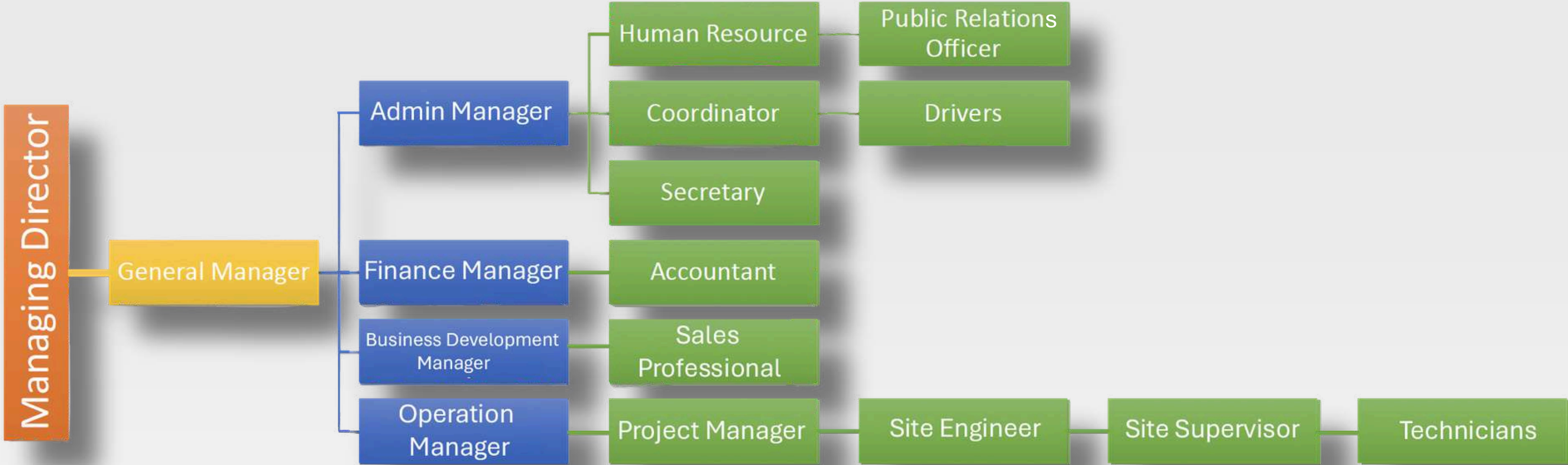

# PROJECT SAFETY PROCEDURES

- Fire prevention

- Site plant & equipment
- Personal protection equipment
- Work at heights
- Storage

Accidents and incidents will be reported, logged and investigated in accordance with company procedures in conformity with existing laws of the country.

Hazard reporting and subsequent action will be executed by surveillance, formal and informal, undertaken by GreenGuard staff on site and visiting safety / management personnel.

Any breaches of procedures or dangerous situation will be notified to the responsible party and corrective action will be taken, and the activity may be halted as a result.

First aiders will be available to all on site and the first aiders will be identified. Emergency procedures will be dependent on the configuration and layout of permanent and temporary works and will be addressed at the safest access / exit in the case of fire.

House keeping and tidiness will be the responsibility of the foreman. Subcontractors will be required to involve in an effective housekeeping policy on site.

Visitors will not be allowed on site without personal protective equipment and they will be accompanied by GreenGuard Group personnel.

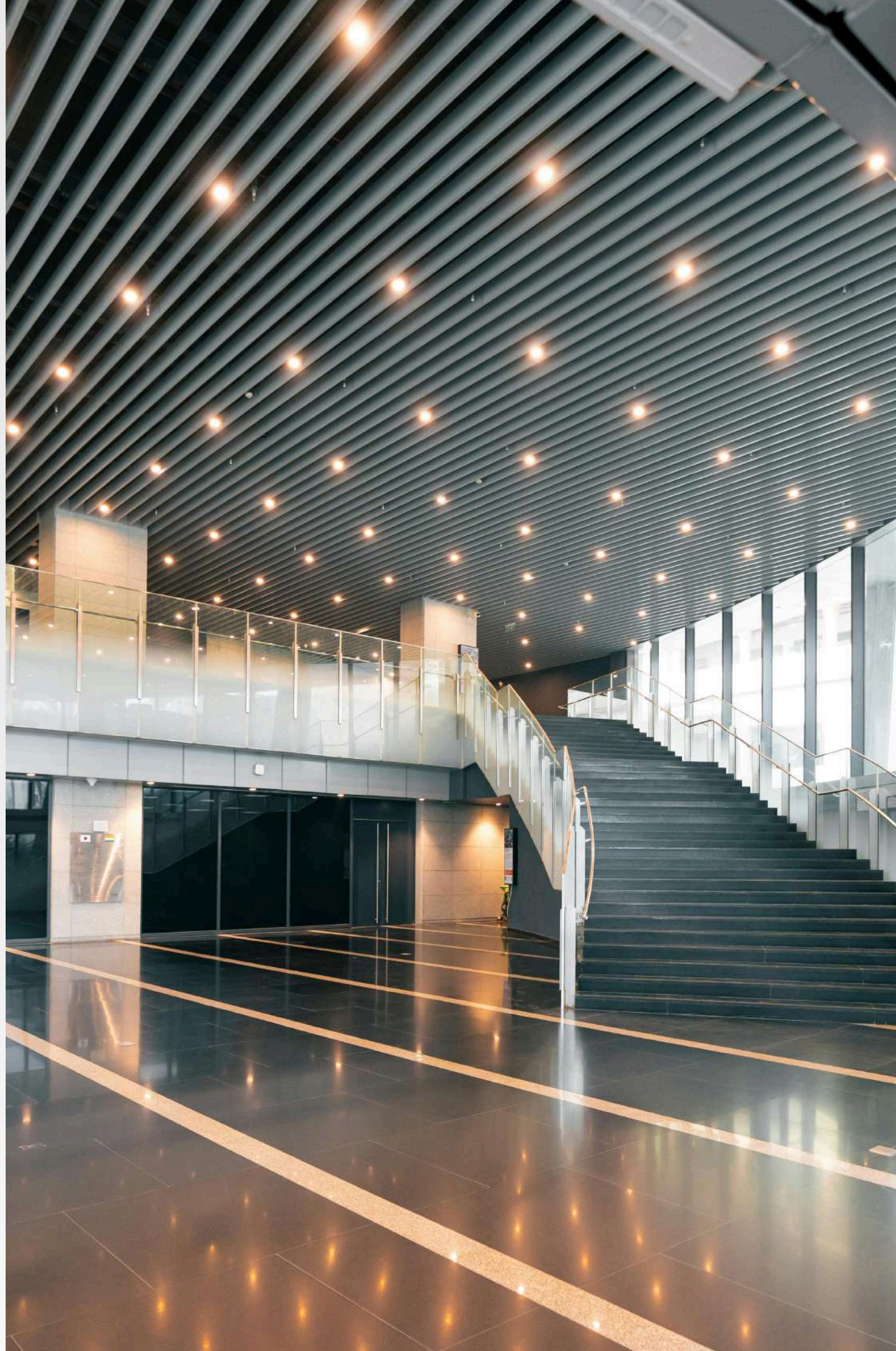
